## **COVID-19 VISITOR GUIDELINE UPDATE**

## **APPENDIX A:** PALLIATIVE/COMPASSIONATE VISITORS

All visitors should obtain a negative COVID-19 test prior to visiting. In scenarios where this is not feasible it can be waived for the initial visit (i.e., rapid decline in patient status) but the family member should obtain the swab ASAP.

All visitors who are coming in for palliative/compassionate reasons should "book" timeslots with the ward clerk/nurse. The number of visitors for palliative/compassionate reasons will be above the existing 8 time slots for essential caregivers. The names of these visitors will be listed in the same book and process used for essential visitors.

Visits for palliative/compassionate reasons can be made outside of "visiting hours" but this will be based on PPS (less than 20%) and patient condition, but will be recorded in the visiting log by the nurse or ward clerk.

To eliminate many visitors waiting around KDH when the PPS is below 20%, it is recommended that the family decide on a schedule allowing 2 visitors at a time for 1 hour slots. This can then be recorded in the visiting log. These timelines can be adjusted depending on the family situation and patient (i.e., 2 visitors for 2 hour blocks etc.) but will decrease the amount of turnover.
